SBA Clarifies REALTOR® Eligibility for SBA-Guaranteed Financial Assistance

The Small Business Administration (SBA) Office of Financial Assistance confirmed to NAR that licensed real estate agents are eligible for SBA-guaranteed financial assistance. The [SBA letter](#) arrived after NAR received reports that some real estate agents who generally operate as independent contractors were denied eligibility for SBA loans. The SBA response also reiterated that real estate brokers are eligible for SBA guaranteed financial assistance. [More...](#)
